## **Product Specific Rules of Origin**

Notes:

1. For goods classifiable under provisions for scrap and wastes, and those scrap and wastes which are not described by name, the origin criteria shall be wholly obtained.

2. Reference to a change in tariff classification in this annex shall apply only to nonoriginating materials.

3."WO" means wholly obtained;

4. "CC" means a change in tariff classification at the 2-digit level;

5. "CTH" means a change in tariff classification at the 4-digit level.
