

ANNEX I

SCHEDULE OF SPECIFIC COMMITMENTS OF THE REPUBLIC OF BELARUS UNDER CHAPTER II (TRADE IN SERVICES)

Explanatory Notes

1. The classification of services sectors in this schedule is based on the 1991 provisional Central Product Classification (CPC) of the United Nations Statistical Office unless otherwise indicated by the absence of a CPC number. The ordering reflects the services sectoral classification list as used in the GATT document MTN.GNS/W/120 dated 10 July 1991. The scheduling of specific commitments follows the guidelines stated in GATT documents MTN.GNS/W/164 dated 3 September 1993 and MTN.GNS/W/164/Add.1 dated 30 November 1993.

2. The use of “***” against individual CPC codes indicates that the service specified constitutes only a part of the total range of activities covered by the CPC concordance. The use of “*” against the specific commitment indicates lack of technical feasibility (hereafter in the meaning of paragraph 47 of the WTO document “Guidelines for the scheduling of specific commitments under the GATS” dated 28.03.2001 (S/L/92).

3. The list of commitments below (hereinafter referred to as “this Schedule”) indicates the service sectors liberalised pursuant to Article 2.14 (Schedule of Specific Commitments), and, by means of reservations, the market access and national treatment limitations that apply to services and service suppliers of the People’s Republic of China in those sectors. This Schedule is composed of the following elements:

(a) the first column, which indicates the sector or subsector in which the commitment is undertaken by the Republic of Belarus, and the scope of liberalisation to which the reservations apply;

(b) the second column, which describes the applicable reservations to Article 2.11 (Market Access) in the sector or subsector indicated in the first column;

(c) the third column, which describes the applicable reservations to Article 2.12 (National Treatment) in the sector or subsector indicated in the first column; and

(d) the fourth column, which describes specific commitments on measures affecting trade in services not subject to scheduling under Article 2.11 (Market Access) and Article 2.12 (National Treatment).

4. This Schedule does not include measures relating to qualification requirements and procedures, technical standards and licensing requirements when they do not constitute a market access or a national treatment limitation within the meaning of Article 2.11 (Market Access) and Article 2.12 (National Treatment). Those measures (e.g. need to obtain a license, universal service obligations, and to obtain recognition of qualifications in regulated sectors, and need to pass specific examinations, including language examinations and need to have a legal domicile in the territory where the economic activity is performed), even if not listed, apply in any case to services and service suppliers of the People’s Republic of China.

5. For services sectors, sub-sectors or activities where importation and (or) exportation of goods might be an integral part of the supply of services, such as distribution services, maintenance and repair services, and technical testing and analysis services, rental and leasing services, the Republic of Belarus, even if not listed in this Schedule, does not undertake commitments of foreign trade and (or) customs measures with regard to goods.

6. For transparency reasons, commitments of the Republic of Belarus under Commercial presence under this Schedule are composed of two following elements:

(a) horizontal commitments, which envisage the possibility to establish commercial presence (in accordance with conditions set in this Schedule) through 3 types of business or professional establishment, including

(i) legal person of the Republic of Belarus;

(ii) representative office established in the Republic of Belarus by a legal person of the People's Republic of China;

(iii) branch established in the Republic of Belarus by a commercial legal person of the People's Republic of China (starting from 1 January 2025).

(b) sectoral-specific commitments, which indicate specific requirements on commercial presence in the sector or subsector in which the commitment is undertaken by the Republic of Belarus.

Entry "None" in the sectoral-specific part under Mode 3 means that all 3 (i)-(iii) types of business or professional establishment are permitted. Entry "None, except for the following: - commercial presence is allowed in the form of a legal person of the Republic of Belarus" under Mode 3 means that among 3 types of business or professional establishment only (i) legal person of the Republic of Belarus is permitted. In the horizontal part of the Financial Services Section and Transport Services Sections of this Schedule special terms and types of business or professional establishment for commercial presence are specified.
